- Don Elliot, SPS Director of IT is retiring after 33 years;
- SPS is hosting the Versaterm Conference 2022 on September 27 to 29, 2022 in Saskatoon. Versaterm is a record management provider that is used by SPS; and
- Attended the Saskatchewan Order of Merit in Regina, SK. Two recipients connected to the Saskatoon Police Services received the honour:Shirley Isbister, member, Saskatoon Police Service Indigenous Women's Advisory Circle and Harry Lafond, Elder, Chief's Advisory Committee;

- The Saskatoon Police Service and the Saskatchewan Serious Incident Response Team will be investigating the death of Myles Sanderson while in RCMP custody;
- Recently finalized an agreement with the Office of the Treaty Commissioner to provide an initiative called Truth and Reconciliation Pathways. This initiative will look for gaps and build a path forward to help build a response to SPS treaty relationship;
